## ORDER:

The Hon'ble Minister Public Works, Highways and Minor Ports Department has made the following announcement on 12.04.2022 on the floor of the Assembly during the Budget demand of Highways and Minor Ports Department during the year 2022-2023.

பெருநகர சென்னை மாநகரப்பகுதியில், உள்வட்டச் சாலையில், செந்தில் நகர் சந்திப்பு, டெம்பிள் பள்ளி சந்திப்பு, கேந்த்ரிய வித்யாலயா பள்ளி மற்றும் நெல்சன் மாணிக்கம் சாலை சந்திப்பு ஆகிய இடங்களில், நகரும் படிக்கட்டுகளுடன் கூடிய நடைமேம்பாலம் ரூ.56 கோடி மதிப்பில் அமைக்கப்படும்.

- 2. In the letter read above, the Chief Engineer (H) (FAC), Metro has stated that the Senthil Nagar junction is a major location on Inner Ring Road / 200 feet road which connects major educational institutions and hospitals on either side of Inner Ring Road. The Foot Over Bridge is proposed to connect Senthil Nagar and Kumaran Nagar at km 14/2 of Inner Ring Road. This is a four-way junction with signalled pedestrian crossing. This Inner Ring Road acts as a gateway to Chennai city by connecting Chennai port and majority of trucks and containers are plying on the road. For the safety of pedestrians a provision of foot over bridge at this location is necessity.
- 3.The Chief Engineer (H) (FAC), Metro has therefore requested the Government to accord Administrative Sanction for a sum of Rs.16.22 Crore for the work of "Construction of Foot Over Bridge with Escalator at Km 14/2 of Inner Ring Road at Senthil Nagar junction".
- 4. The Government after carful examination, accept the proposal of the Chief Engineer(H) (FAC), Metro and hereby accord Administrative Sanction at a cost of Rs.15.42 Crore (Rupees Fifteen Crore and Forty Two lakh only) for the work of "Construction of Foot Over Bridge with Escalator at Km 14/2 of Inner Ring Road at

Senthil Nagar junction" and accord financial sanction for a sum of Rs.20,00,000/-(Rupees Twenty Lakh only) in the current financial year 2022-2023. The balance amount will be released in the subsequent financial years based on the requirements.

5. The expenditure sanctioned in Para-4 above, shall be debited under following head of account:-

"5054 -Capital outlay on roads and bridges - 80-General-800 Other Expenditure-State's Expenditure – JW – Chennai Development Plan- Traffic and Transport Improvement in Chennai City-416- Major Works – 01 Major Works"

- 6. The expenditure sanctioned in Para 4 above is an item of "New Instrument of Service". The approval of the Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure may be initially met by drawl of an advance from the Contingency Fund. The Chief Engineer (Highways), (FAC), Metro, Highways Department is directed to calculate the actual amount required for the period upto next Supplementary Estimates and apply for sanction of the same as advance from the Contingency Fund to Finance (B.G-1) Department directly in Form 'A' appended to the Tamil Nadu Contingency Fund Rules, 1963 along with a copy of this order. Orders for sanction of an advance from the Contingency Fund will be issued from Finance (B.G-I) Department. He is also directed to send a draft explanatory notes for including the above expenditure in the Supplementary Estimates 2022-2023 to Finance (BG-I/PW-1) Department without fail.
- 7. This order issues with the concurrence of Finance department vide its U.O.No.40034/Fin(PW-1)/2022, dated 02.09.2022 and Additional Sanction Ledger No.1132 (One Thousand One Hundred and Thirty Two) (IFHRMS ASL No.2022091132).
