ORDER:

In the Government Order first read above, among other orders, Government have accorded Administrative Sanction for Land acquisition for a sum of Rs.10.00 crore for “Forming six lane of ECR from Km 11/800 – 23/200 of Thiruvanmiyur to Akkarai”.

2. In the Government Order second read above, Government have accorded Revised Administrative Sanction for a sum of Rs.354.66 crore for the work of “Forming six lane of ECR from Km 11/800 – 23/200 of Thiruvanmiyur to Akkarai”.

3. In the Government Order third read above, Government have accorded Revised Administrative Sanction-II for a sum of Rs.778.00 crore for the work of “Forming six lane of ECR from Km 11/800 – 23/200 of Thiruvanmiyur to Akkarai”.

4. In the Government Order fourth read above, Government have accorded a sum of Rs.219.92 crore for the work of "Construction of Grade Separator at the intersection of Lattice Bridge Road and East Coast Road at Thiruvanmiyur junction".

5. In the letter sixth read above, the Chief Engineer (H), Metro has stated that the stretch from km 11/800 to km 23/200 of the ECR starts at Thiruvanmiyur and ends near Akkarai via Kottivakkam, Palavakkam, Neelangarai, Injambakkam and Sholinganallur Villages and the Land Acquisition works on these villages are in various stages.

6. The Chief Engineer (H) (FAC), Metro has stated that the stretch from Km 11/800 – 13/615 is covered in the work of "Construction of Grade Separator at the intersection of Lattice Bridge Road and East Coast Road at Thiruvanmiyur junction", which is sanctioned in Government Order 4th read above.

7. The Chief Engineer (H), Metro has also stated that the Land Acquisition was completed in the stretch from Km 14/550 - 15/700 at Palavakkam Village and Administrative sanction has also been accorded for the sum of Rs. 15.85 crore for the work of "Widening the East Coast Road (ECR) to six lane from Km 14/550-15/700 at Palavakkam Village", vide Government Order fifth read above.

8. The Chief Engineer (H), Metro has also stated that for the in-between stretch from Km 13/615 - 14/550 at Kottivakkam village" Land Acquisition Award has been pronounced on 29.01.2021 and compensation is being paid to land owners.

9. The Chief Engineer (H), Metro has therefore requested the Government to sanction a sum of Rs.18,57,00,000/- as Administrative Sanction for the work of "Widening the East Coast Road (ECR) to six lane from Km 13/615 - 14/550 at Kottivakkam village".

10. The Government after careful examination, accept the proposal of Chief Engineer (H) (FAC), Metro and accord Administrative Sanction at a cost of Rs.17,16,00,000/- (Rupees Seventeen crore and sixteen lakh only) for the work of "Widening the East Coast Road (ECR) to six lane from Km 13/615 - 14/550 at Kottivakkam Village", as detailed below; and accord financial sanction for a sum of Rs.2,00,00,000/- (Rupees two crore only) in the current financial year 21-22 and the balance amount will be released based on the requirement.

11. The expenditure sanctioned in para-10, above shall be debited to the following head of account:-

"5054 – Capital Outlay on Roads and Bridges – 80 General – 800 – Other Expenditure – States Expenditure – JW – Chennai Metropolitan Development Plan – Traffic and Transport Improvement in Chennai City – 416. Major works – 01. Major Works"

12. The Chief Engineer (H) (FAC), Metro is authorized to incur the expenditure sanctioned in para-10 above.

13. The expenditure sanctioned in Para 10 above shall constitute an item of "New Instrument Service" and approval of the Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure will be initially met by an advance from the Contingency Fund. The Chief Engineer (Metro) (FAC), Highways Department is directed to calculate the actual amount required for the period upto next Supplementary Estimates and apply for sanction of the same as advance from the Contingency Fund to Finance (B.G-I) Department directly in Form 'A' appended to the Tamil Nadu Contingency Fund Rules, 1963 along with a copy of this order. Orders for sanction of an advance from the Contingency Fund will be issued from Finance (B.G-I) Department. The Chief Engineer (Metro) (FAC), Highways Department is also directed to send a draft explanatory notes for inclusion the above expenditure in the Supplementary Estimates 2021-2022 to Finance (BG-I/PW-I) Department without fail.

14. This order issues with the concurrence of Finance Department vide its U.O.No.54910/PW-I/2021 dated:13.12.2021 and Additional Sanction Ledger No.1132 (One thousand one hundred and thirty two).


