ORDER:

During the budget session 2021-22, the Hon'ble Minister for Public Works, Highways and Minor Ports made the following announcement in the floor of the Assembly on 27.08.2021.

- 2) In the Government Order 1st read above, orders were issued to accord Administrative Sanction for the acquisition of land for the "Formation of Bypass to Ambasamudram town" for a length of 6.049 km for an amount of Rs.2728.69 Lakhs.
- 3) The Chief Engineer (H), NABARD and Rural Roads in his letter second read above has stated that the announcement proposal for "Formation of Bypass to Ambasamudram Town" is as follows:-

The proposed bypass starts at km 86/2 of SH 40 (Tiruchendur – Palayamkottai – Ambasamudram – Tenkasi – Courtrallam – Shenkottai Road) and joins with the same road of SH 40 at km 92/550. The existing SH 40 at these locations, are of two lane with paved shoulders. Hence to have smooth and free flow of traffic, same configuration of carriageway is followed. Moreover, the projected traffic for 2021 is 17466 PCU, which warrants two lane with paved shoulder as per CI.10.3 of IRC:64-1990. Now the Bypass road has been proposed with two lane (7.00 m) carriageway with 1.50m paved and earthen shoulder of 1.50m on both sides. The total width of formation is 13.00m at top.

- i. The proposed Bypass starts at km 86/2 of Tiruchendur Palayamkottai Ambasamudram Tenkasi Courtrallam Shenkottai Road (SH 40) and crosses Ambai Karumpuliyuthu road (ODR) at Ch:3120m & Ambai Alangulam road (SH 40-B) at Ch:4080m and ends at km 92/550 of Tiruchendur Palayamkottai Ambasamudram Tenkasi Courtrallam Shenkottai Road(SH 40) of SH 40 thus forming a length of 6.049 km. The proposed alignment crosses Canadian Canal at Ch:50m and also crosses the Tamirabarani river at Ch:1935 min square direction.
- ii. As the proposed Bypass road crosses one ODR and one State Highway (SH) road, two junction improvements have been proposed at these two crossings and other two junction improvements, one at the starting chainage and another at the ending chainage have also been proposed where the bypass merges with Tiruchendur Palayamkottai Ambasamudram Tenkasi Courtrallam Shenkottai Road (SH 40).
- iii. A High level bridge having ten spans of 20.00m c/c with RCC T-beam cum slab super structure is proposed across Tamirabarani river. The carriageway of the proposed bridge is 11.0m with footpath, inner crash barrier and handrails on both sides, forming a total width of 16.00m.
- iv. A minor bridge having 4 spans of 10.00m c/c with RCC T-beam cum slab super structure is proposed across Canadian Canal. The carriageway of the proposed bridge is 2x7.50m with median for 1.50m and the roadway is 21.00m including footpath, inner crash barrier and handrails on both sides.
- v. Apart from the above, 16 box culverts of size 2m x 2m, one box culvert across unlined canal of size 6x3m and two balancing box culverts of size 5.00m x 5.50m are proposed at Ch:4780 & 4920 to facilitate cross drainage since the entire bypass runs through field. Necessary lumpsum provisions such as utility shifting, bus shelters, demarcation, overhead gantry, avenue plantation, price escalation, advertisement charges, labour welfare, quality control charges, road safety audit, white washing, lighting arrangements, bus lane, variation in depth of foundation and petty supervision & contingencies as per norms are included in the proposal.
- vi. The above work land acquisition is involved in the five villages namely Therku Kallidaikurichi, Vadakku Kallidaikurichi, Mela Ambasamudram, Vagaikulam and Keela Ambasamudram as follows:-

- 4) The Chief Engineer (H), NABARD and Rural Roads has therefore requested the orders of the Government to accord Administrative Sanction for a sum of Rs.66,70,00,000/- for the "Formation of Bypass to Ambasamudram Town".
- 5) The Government after careful examination, accept the proposal of the Chief Engineer (H), NABARD and Rural Roads and accord Administrative Sanction for the work of "Formation of Bypass to Ambasamudram Town" for an amount of Rs.65,99,00,000/- (Rupees Sixty Five Crore and Ninety Nine Lakh Only) under the CRIDP Bank of sanction for the year 2022 2023.
- 6) This order issues with the concurrence of Finance Department vide its U.O.No.12819/PW-I/2022, dated.28.03.2022.
