ORDER:

In the Government order first read above, orders were issued constituting a Committee consisting representatives of Finance Department, Highways and Minor Ports Department, Director General and concerned Chief Engineers of Highways Department for scrutiny and review of the Revised Administrative Sanction proposals.

2. In the Government order second read above, Administrative Sanction was accorded for the “Land Acquisition for the Formation of Bypass road to Mayiladuthurai Town” for an amount of Rs.2,06,68,365/- under Revamped Central Road Fund 2010-2011. Subsequently in the Government order third read above, 1st Revised Administrative Sanction was accorded for the above work for an amount of Rs.2133.00 Lakhs.

3. The Committee on Revised Administrative Sanction in its meeting held on 04.03.2020, approved the following proposals of Chief Engineer (Highways) NABARD and Rural Roads

The Chief Engineer (Highways) NABARD & Rural Roads has therefore requested the Government to approve the 2nd Revised Administrative Sanction for the work of "Land Acquisition for the Formation of Bypass road to Mayiladuthurai Town starting at km 28/6 of Kumbakonam-Sirkali Road and ending at km 4/4 of Mayiladuthurai-Thiruthuraipoondi Road" for an amount of Rs.57,00,00,000/- based on the recommendation of the Revised Administrative Sanction Committee.

5. The Government after careful examination, accept the proposal of the Chief Engineer (Highways) NABARD and Rural Roads as recommended by Revised Administrative Sanction Committee and accord 2nd Revised Administrative Sanction for a sum of Rs.57,00,00,000/- (Rupees Fifty Seven Crore only) for the "Land Acquisition for the formation of Bypass road to Mayiladuthurai Town starting at km 28/6 of Kumbakonam-Sirkali Road and ending at km 4/4 of Mayiladuthurai - Thiruthuraipoondi Road", as against the 1st Revised Administrative Sanction amount of Rs.21,33,00,000/-, and also accord Financial Sanction for a sum of Rs.35,67,00,000/-.

6. The expenditure sanctioned in para-5 above shall be debited to the following Head of account from the existing budget provision.

"5054- Capital Outlay on Roads and Bridges – 04- District and Other Roads- 337-Road Works – State's Expenditure-KA Bypass works- 464 Lands-01. Lands.
