The Director General, Highways Department has requested that there shall be no change in the delegation of powers to the Chief Engineer (H), Planning and to prepare and accord Technical Approval for detailed structural designs, drawing and quantity estimates for design-oriented works, for works above Rs.2.00 Crore considering the structural safety and serviceability of the structures.
- 4. The Director General Highways Department has therefore requested the Government to revise delegation of powers for Technical Sanction to Divisional Engineers, Superintending Engineers and Chief Engineer of Highways Department.
- 5. The Government after careful examination, have decided to revise the delegation of powers for Technical Sanction for Divisional Engineers, Superintending Engineers and Chief Engineers for road works as indicated below:-
